- 5. Received public relations materials from librarian outlinging activities carried on these past months
- 6. Correspondence:
  - a. Notice of October 25, 1980 Manitoba Library Trustees Association annual meeting to be held at Dauphin. Delegate Edra Johnson will not be attending and has so advised chairperson M. Lorimer. Discussion: Flin Flon hosted the 1979 annual meeting which local board feels is not actually a necessary exercise. Consesus of opinion is that more benifit is gained by having the Librarian attend various seminars that will enhance her technical skills.
  - b. Neon Products Ltd. provide a 30 day quotation for a single face sign for the Library \$1660.00 plus Federal & Provincial taxes, and scanty detail about extra for "service wiring." Additional detail is required. S. Sattleberger & M. Johnson, "That we contact the city engineer and the designers for requirements and specifications for installation of a sign which the Board Members recommend purchase at the quoted price."
- 7. Building reported by Librarian to be functioning well including use of Rotary Room, Savin Copier, and that a painting schedule along with contractor quotations should be gone into. No motion was made due to concern about winter not being suitable time for painting interior
- 8. Salary review due by January 1981. Flin Flon wage scale much less than Thompson.
